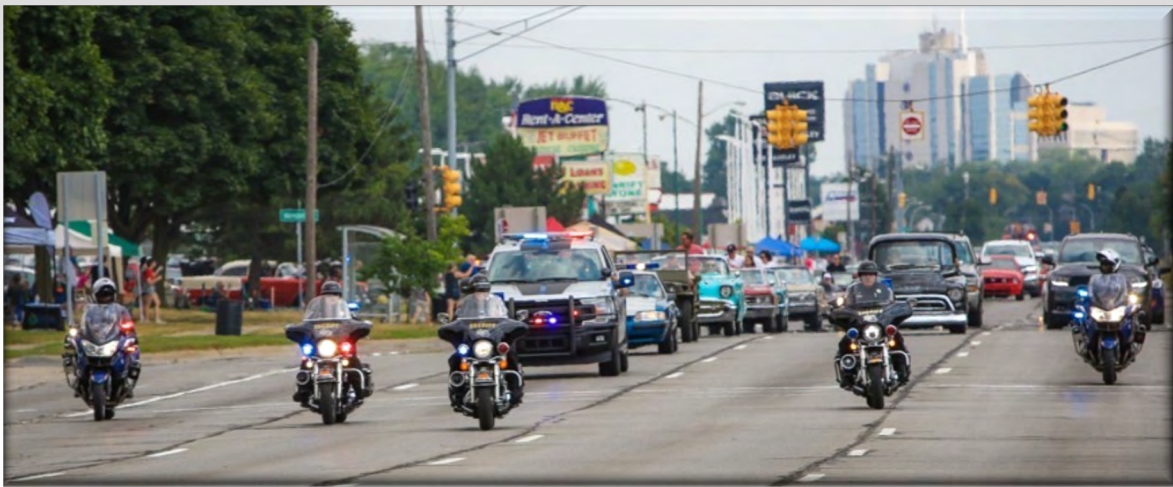

This year has been a busy year at the Macomb County Sheriff's Office. I am proud to be your Sheriff and also proud of the men and women who work for our office. They truly are dedicated individuals that ensure the safety of all Macomb County residents and those who work, travel and play here.

In 2019, we completed our plan for a new facility that would house both the Corrections and Law Enforcement components of my office. The project was approved this year and we will ask voters for approval of a millage in 2020. The new facility will move to a Direct Supervision model while supervising prisoners and provide adequate housing and services for those inmates with mental health and medical issues. We will wait and see what the voters decide in 2020.

The Law Enforcement section continues to expand with additional Deputies being hired in our contracted communities. Our 911 Dispatch Center has added full-service dispatch to several Fire Departments, in which law enforcement services are provided by MCSO. Our Special Units continue to perform at an exemplary level. They continue to train and keep current with issues, laws, and tactics that our ever changing in our profession.

The Sheriff's Office is tasked with Court Security at the Circuit and District Court levels, as well as transporting incarcerated inmates to their court hearings throughout the County. Inmates are also taken to doctor appointments for treatment outside the jail and our court services section picks up prisoners arrested on warrants anywhere in the State. As you can imagine, the men and women in this unit drive thousands of miles a year while maintaining the safety and security of prisoners while on the road.

This Annual Report details our official statistical data and budgetary information to help us plan for the future, deploy our resources where they are needed, and most importantly be transparent to the public in all aspects of the Macomb County Sheriff's Office operations.

I thank each member of the Sheriff's Office for a job well done in keeping Macomb County safe.

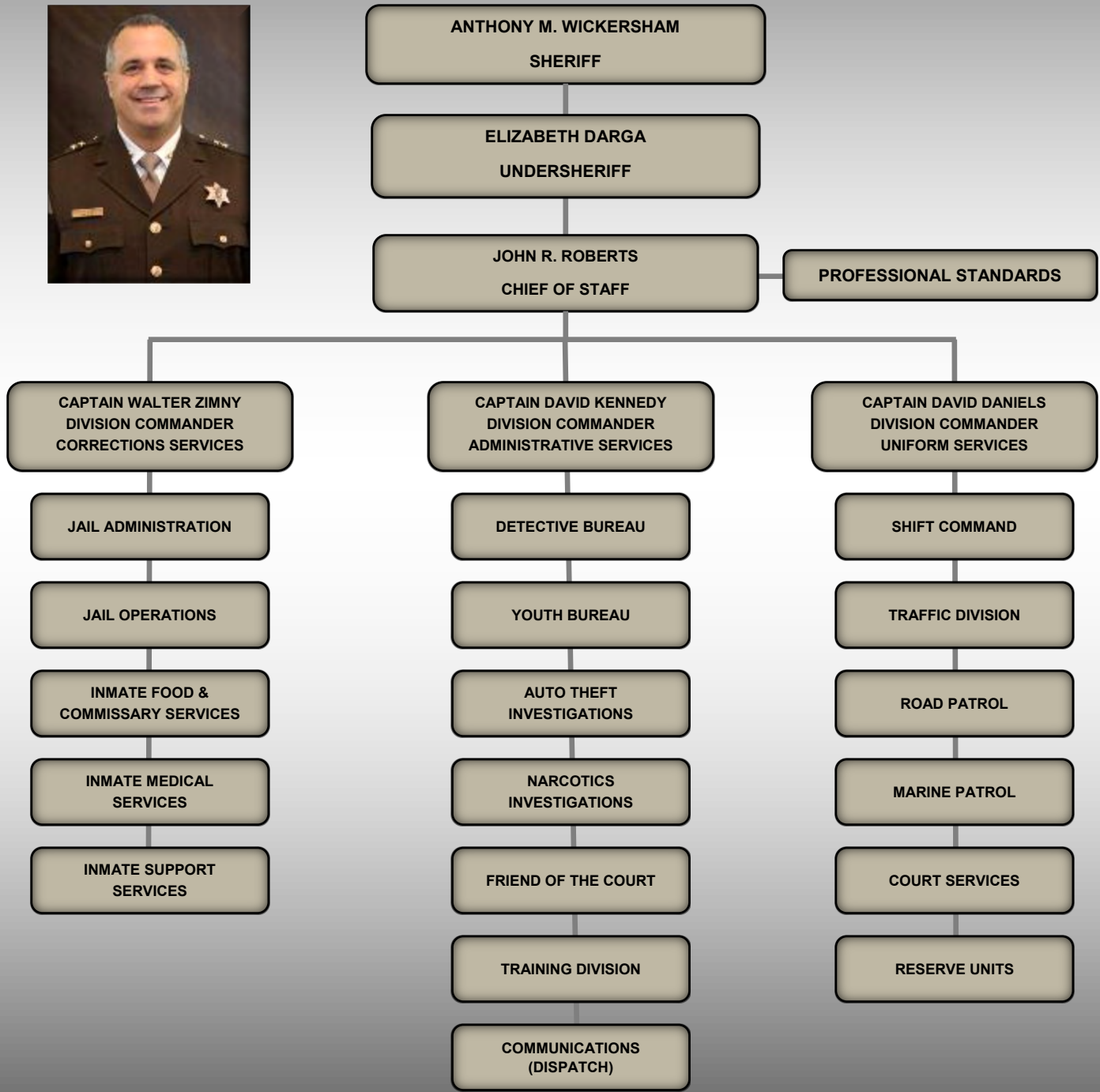

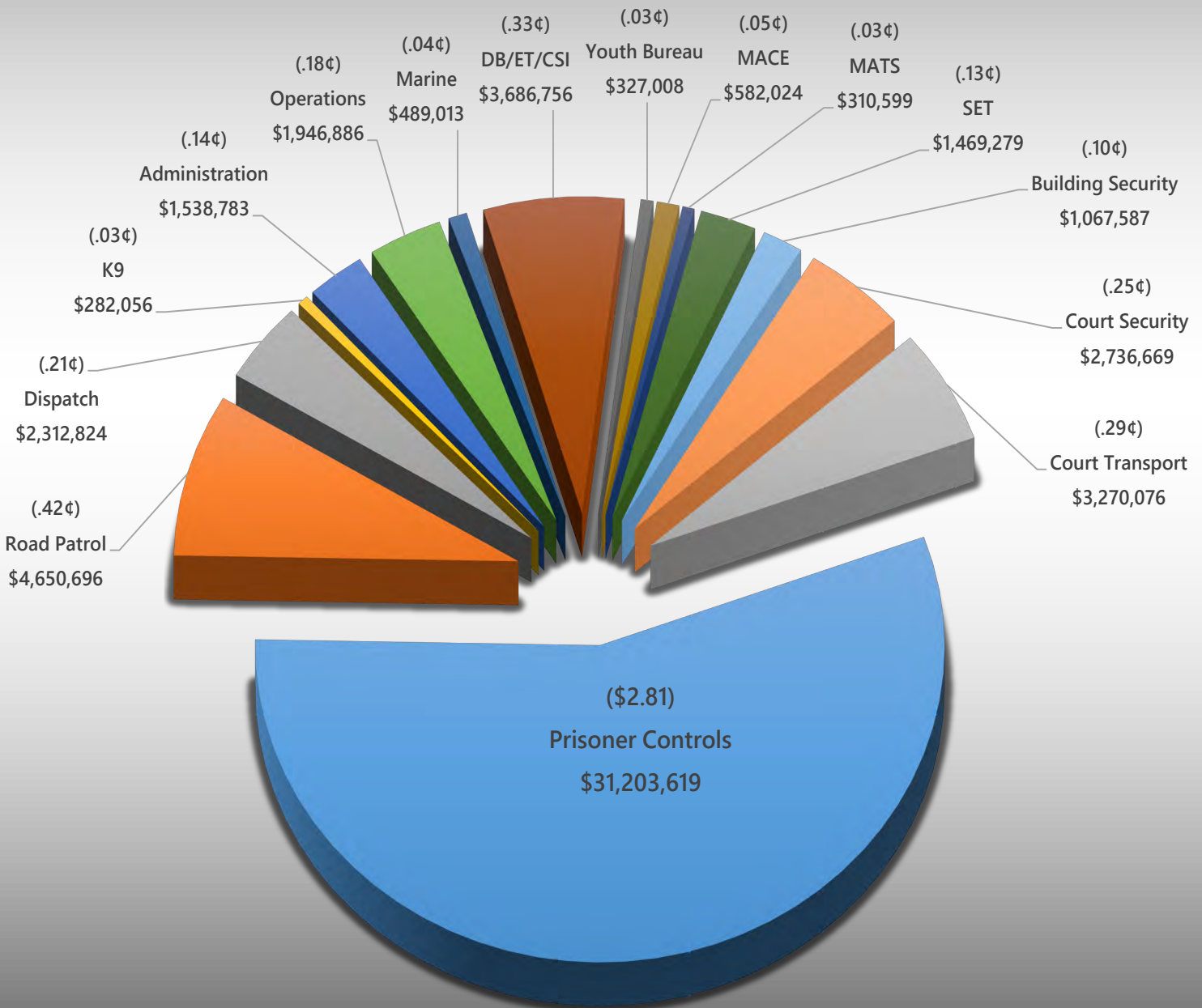
# Organizational Chart



# Sheriff's Office Budget

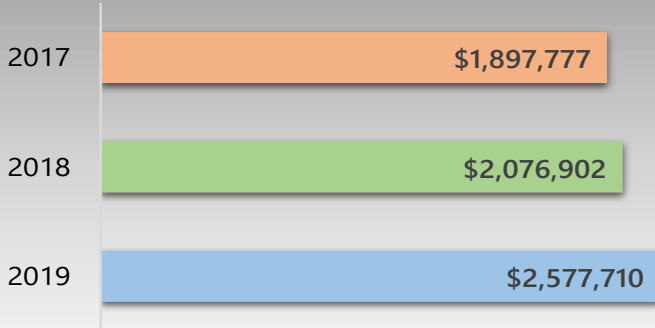
2019 Sheriff's Net Budget - By Unit

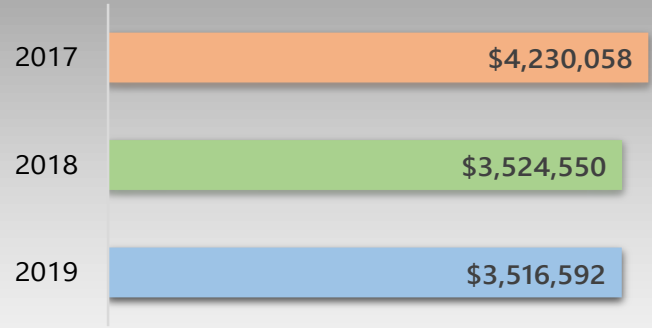

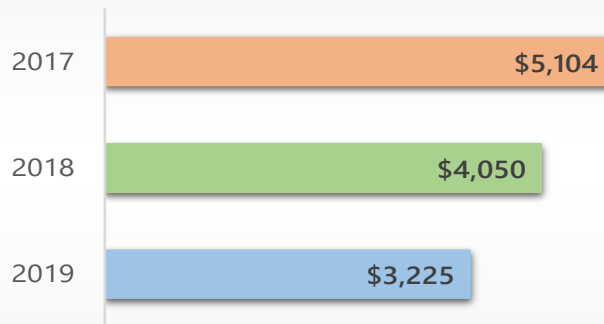
2017-2019 Reimbursement Grants Law Enforcement

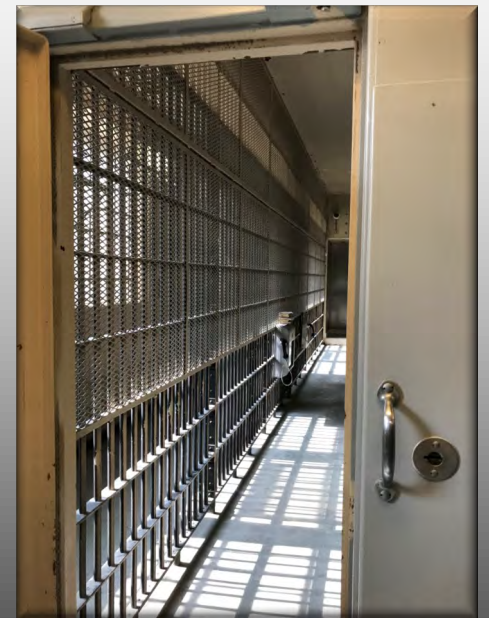

# Jail Operations

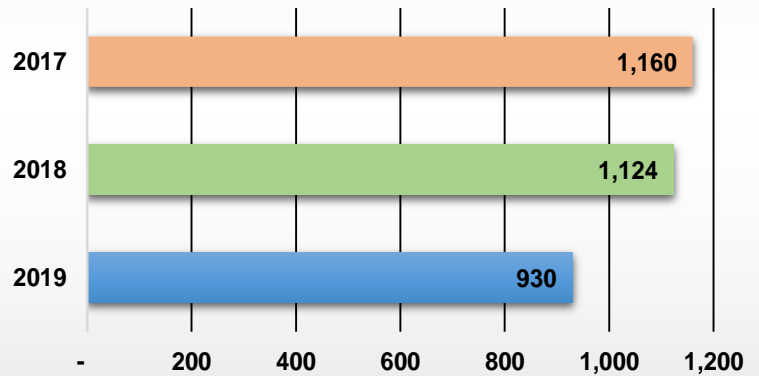


The Macomb County Jail is staffed by Deputies, Command Officers and support staff. These individuals are responsible for the care and custody of all prisoners, the well-being of staff, and maintaining security and order within the jail facility.

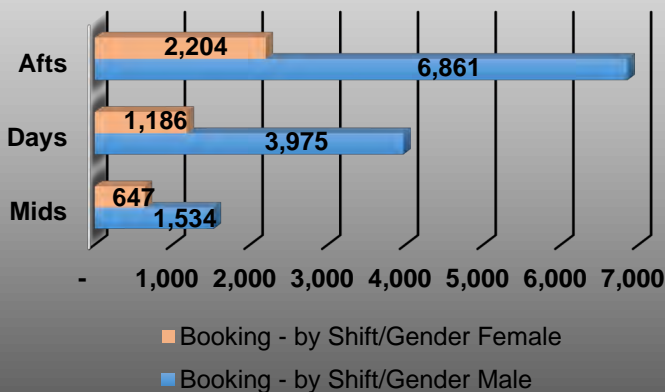
All courts through their Jail Bed Allocation plan and alternative sentencing assist in keeping the jail population below the design capacity. The jail's Rated Design Capacity is 1,201.

In 2019, a total of 16,407 new prisoners were booked into this facility. That number consisted of 12,375 males and 4,032 females. Of those booked, 40% were felony charges and 45% were misdemeanor charges and 15% were non public or miscellaneous. There were 16,570 inmates released during 2019.

## Prisoner Information



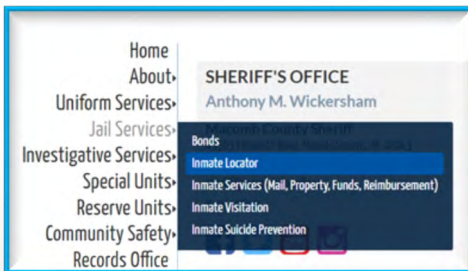
Our Jail Office staff is responsible for inmate tracking for bookings, releases, bonds, transports, court dispositions, sentences, and processing Sex Offender Registrations.

In 2019, our staff added 25,814 charges, disposed of 25,321 charges, updated court information on 32,120 inmate files, added 15,500 holds and added 6,127 sentences to inmate files.



They also handled \$1,356,329 in bond monies and collected \$1,490 in warrant collection fees.

The Inmate Locator application is available to the public allowing you to check on inmate status, bond information, and visiting information.



The Inmate Locator is accessible through the internet at the Macomb-Sheriff.com website.



Video Visitation by ICSolutions is an innovative solution that provides an alternative to traditional, face-to-face inmate visitation in the Macomb County Jail.

Video visitation sessions provide added value and security to our facility by removing the necessity to transport inmates for traditional onsite visitations and allows friends and family members to conduct onsite visits from a kiosk in our jail's annex as well as offsite video visitation sessions from the comfort of the visitor's home using a personal computer or laptop.

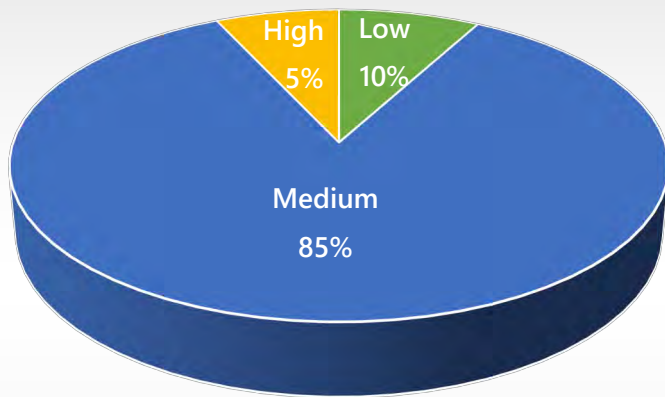

## Classification Bureau

The Macomb County Sheriff's Office utilizes an objective classification plan to provide fair and consistent guidelines in determining prisoner assignments to housing areas, security level, treatment and program services. Original classifications and periodic reviews are performed to accommodate changes in charges, behavior, and to better align the jail population.

## Inmate Food Services

Continental Canteen provides food services for the Macomb County Jail. Prisoner trustees help with food preparation and serving. These services include basic meals and commissary sales. Meals cost approximately \$1.18 cents per meal based upon the population count of inmates. Cost savings continue to be sought.

## Inmate Health Services



Correct Care Solutions Inc. provides medical, mental health, dental and related healthcare to inmates at the Macomb County Jail. Some of the services include preliminary screening of inmates upon arrival, a comprehensive health evaluation, regularly scheduled sick call, 24-hour nursing coverage, physician visits on-site, hospitalization, medical specialty services and administrative support. Approximately \$6.6 million dollars was spent in 2019 for prisoner healthcare.

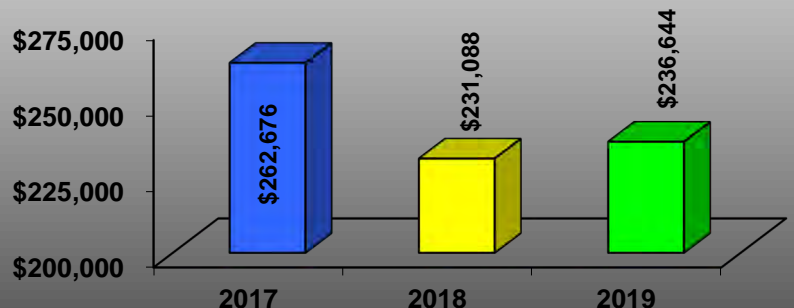

## Jail Reimbursement Program

In 1985, the Jail Reimbursement Program (Pay-to-Stay) was implemented at the Macomb County Jail. The purpose of the program is to seek reimbursement from inmates to help defray the cost of housing.

## Correctional Education

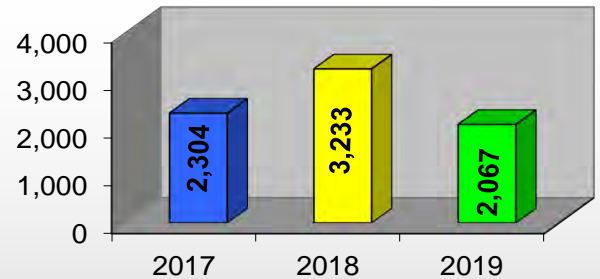
## Substance Abuse Program

Clinton Counseling is the contracted vendor that provides substance abuse treatment for incarcerated individuals. They are a licensed outpatient program designed to assist individuals housed in the Macomb County Jail with overcoming physical and psychological dependence to drugs and alcohol.

Beginning in October 2019, the substance abuse programming in the jail changed.

Fast Track remained available, and the Extended Track program was replaced by the Reentry Track program. The admission process for Reentry Track is quick, allowing more people to obtain services. Reentry Track is designed to teach life skills and provide the resources necessary to prepare inmates for their release back into the community.

# Jail Operations

## Community Corrections

Macomb County Community Corrections is a community based sanction and rehabilitative program aimed at relieving prison and jail overcrowding through Court-approved sentencing alternatives. Non-violent offenders are placed into community sanctions, rather than in jail or prison, to allow for corrections space for more serious offenders. Rehabilitative and monitoring options include substance abuse inpatient and outpatient treatment, monitoring services, substance use testing, community service work, cognitive programming and pre-trial release supervision.



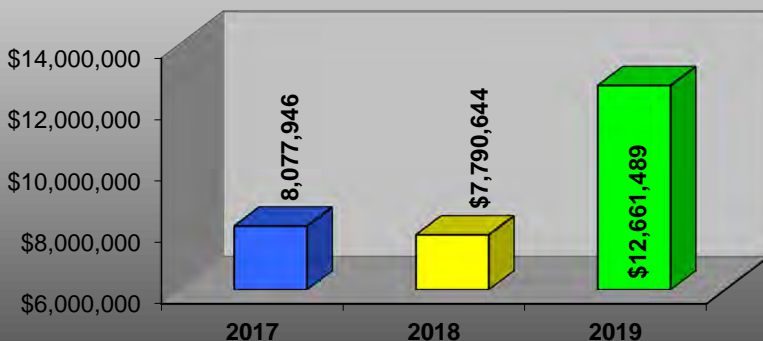

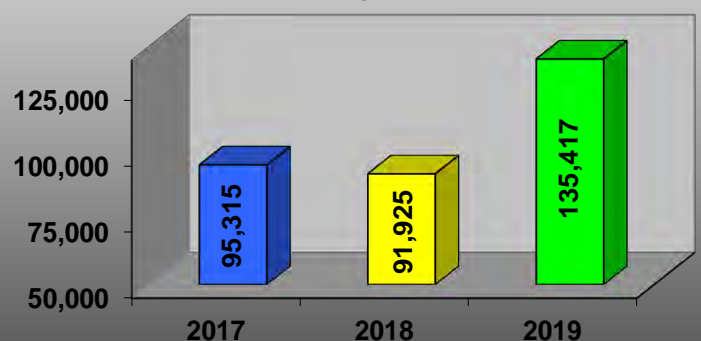

The intent of this program is to link offenders with services and support outside of the jail to ensure that all aspects of their mental health treatment are being met.

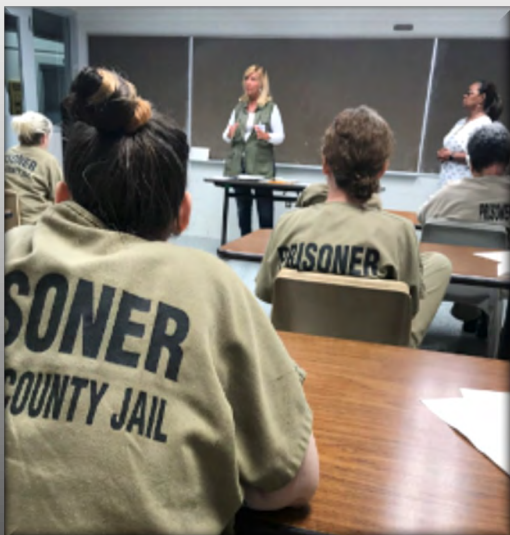

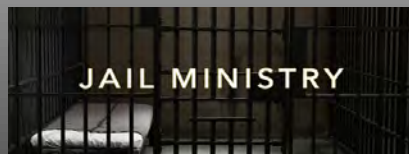
## *Jail Ministry*

The Macomb County Jail Ministry Team consists of 59 volunteers which includes 2 Chaplains, 35 Bible Study teachers, and several miscellaneous personnel. These volunteers come from various denominations in the community.



In addition to 1,445 Clergy visits, the Macomb County Jail Ministry Team conducts regular religious services. During the year 2019, 509 worship services were conducted with 5,128 inmates attending.

The Ministry program also provides Bibles, clothing for released inmates, a book library, stamped envelopes, bus tickets and food certificates upon release. Prisoners also receive Christmas and Easter gifts from the Jail Ministry team.

# Uniform Services

## Uniform Services Section

The Uniform Services Division includes a 911 Dispatch Center, Traffic Bureau, Court Security, Prisoner Transport, K-9, Marine Division, Dive Team, Liquor Control Enforcement, Reserve Deputies, and Fleet Management.

Eight communities contract with the Macomb County Sheriff's Office for 24/7 police services and/or dispatch services.

Emergency response is provided in four townships that do not have police departments. They are Armada, Bruce, Ray and Richmond Townships.

The Sheriff's Office also responds to any nearby local, state or federal agency which requests assistance.

## Honor Guard



The Honor Guard's mission is to enhance the professional image of the Macomb County Sheriff's Office, and the County of Macomb. The unit's first priority is to honor and pay respects to fallen Officers and their families. Every year they have continued to honor our own fallen officers by participating in wreath laying ceremonies honoring their sacrifice for their communities.

The 19 Honor Guard members dedicate their personal time to attend funerals and memorial services for our Brothers and Sisters in Law Enforcement, Fire Services and EMS that have lost their lives protecting and serving our citizens and our communities.

In 2019, the Honor Guard completed 20 details including National Law Enforcement Memorial Week held every May in Washington D.C. Other details included three retiree casket watches, and two active duty death funerals.

An important part of the Honor Guard is to maintain a professional relationship with are Honor Guards. Three members of the Macomb County Sheriff's Honor Guard participated with two members of the Oakland County Sheriff's Honor Guard in presenting the colors during the national Anthem at the start of the Jimmy John's Charity Softball game in Utica.

All of the financial support has come solely from Honor Guard Members, fundraising, and donations we receive from citizens.

# Uniform Services

## Dispatch Center

In 2019, the backup center located in Warren P.D. was completed. The backup center was a project started in 2018 and is a joint collaboration between the Macomb County Sheriff's Office, Warren Police Department, Macomb County IT, Emergency Management and Macomb County Tech Services. All 12 Dispatch consoles are now fully functional. In COMTEC, four additional dispatch consoles were added for Warren PD should they need to utilize our center for backup operations.

CAD, Mobile and RMS platforms were upgraded to Tyler Technologies newest base software release. This new software release integrated best with Rapid SOS which was implemented in 2018. This integration significantly enhanced our call taking and enhanced call location for Rapid SOS. The Macomb County Sheriff's Office was the first agency to go live with this new release and used the opportunity to be instrumental in the continued development. The transition was seamless and we continue to take pride as always being on the forefront of emerging technology.

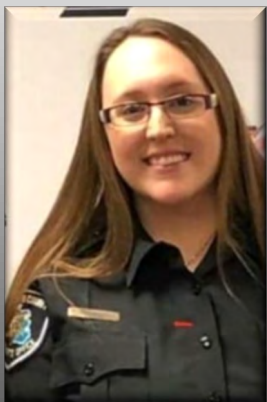
## Dispatch Center

The Macomb County Sheriff's Office also participated in a full scale active shooter scenario training with Clintondale High School and L'Anse Creuse high School. Eight dispatchers participated and were trained in ICS communications, rescue task force operations and procedures. The scenarios involved staged 911 calls and had students and staff acting as victims at the schools. Dispatch received the 911 calls, dispatched resources, maintained radio contact while fil-



tering additional calls and managed mutual aid and rescue task force efforts. This reality based training provided experience and training to all involved. The communications piece of the event was held in the EOC at COMTEC and local media was present for this event.

In addition to Emergency Medical Dispatch certifications, staff also attended a variety of continuing education courses. These courses varied in content from 911 Liability, Combating Negativity in the Workplace, Leadership training, Communications Training Officer, Active Shooter, Emotional Wellness and Customer Service. All Dispatcher training was funded with the State Approved Dispatcher Training Funds and all Dispatchers are in compliance with continuing education credits. Dispatch completed 636 hours of in house training and 1300 hours of outside training in 2019.



On 10/8/19, Dispatcher Erika Ladas died in a car crash on North Ave and 31 Mile Rd. as she was traveling home from the Macomb County Sheriff's Office. A vehicle struck a deer which then struck Erika's vehicle. Erika was only 28, a mother of two, and had a long career ahead of her. Erika had worked for the Sheriff's Office since January of 2019 and was already embedded deep into the MSCO family.

She is greatly missed.



# Uniform Services

## Traffic Bureau

In 2019, the Traffic Bureau was made up of (3) Deputies and (1) Sergeant. Deputy responsibilities include investigating motor vehicle crashes, motor carrier enforcement, traffic enforcement in problem areas, special event details, child seat inspections, dignitary protection, occasional speaking events and enforcing traffic laws throughout the county. Sergeant responsibilities include scheduling, collecting traffic statistics, radar trailer deployment, tracking vehicles and traffic equipment. The Sergeant also attends numerous seminars, traffic related meetings with various organizations as well as managing and applying for all grants.



This year, Macomb County secured \$172,000 in state grant monies from the Office of highway Safety Planning compared to \$186,000 in 2018. This money was used for seatbelt enforcement, impaired driving enforcement, speeding enforcement, red light enforcement and distracted driving enforcement campaigns throughout the year.



During 2019, our agency processed approximately 3,695 vehicles of which 287 went to auction. Every vehicle abandoned or towed by sheriff personnel and not redeemed by the vehicle owner is processed by a certified deputy. In addition, 5 salvage vehicle inspections for residents of our contracted patrol areas were conducted.

In 2019, approximately 35 school bus violations were issued and 2 child seat inspections were performed.

## Traffic Bureau



### Level I – North American Standard Inspections

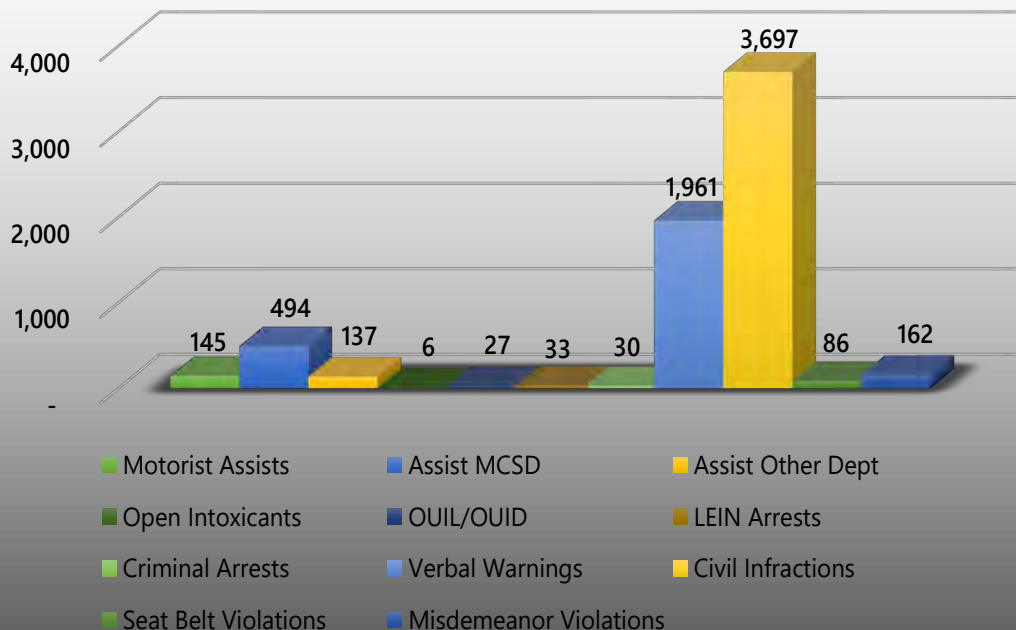
► Most comprehensive of the inspections, it includes examination of compliance with the critical elements of both driver and vehicle regulations. A Level I inspection takes about 45-60 minutes to complete.

Two deputies are certified to conduct Motor Carrier inspections and answer complaints from the Macomb County Road Commission and local agencies to assist in enforcing motor carrier laws throughout Macomb County when requested. One of these deputies is also federally certified and in addition to his daily patrol duties, conducted 34 Level I truck inspections.



In 2019, The Traffic Bureau secured \$481,089 from the Office of Highway Safety Planning for Secondary Road Patrol. This amount is less than what was received in 2018, \$481,089, as we lost on secondary road patrol deputy position due to budget cuts from the previous year.

During 2019 the Traffic Bureau responded to and investigated 630 property damage crashes, 186 personal injury crashes which includes 7 fatal crashes, for a total of 816 traffic crash investigations. The Traffic Division investigated approximately 47% of the total crashes investigated by the entire Sheriff's Office. The Traffic Bureau issued 3,783 total combined violations, gave 1,961 verbal warnings and patrolled over 52,219 miles on Macomb County Roads during 2019.

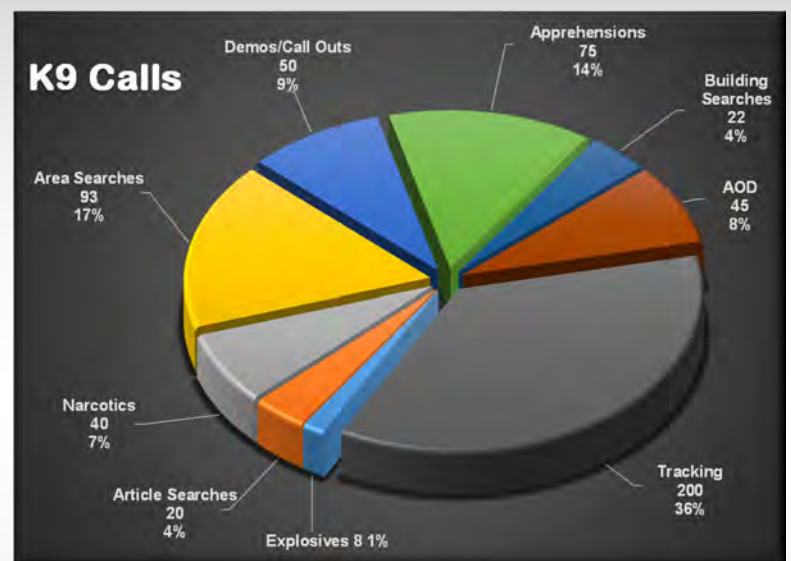

## Canine Unit (K-9)

The Sheriff's Office five K-9 teams have proven to be an effective resource for us as well as for local, state, and federal agencies which we assist. K-9 teams are utilized to locate lost persons, track suspects from crime scenes, locate narcotics and articles, suspects that are hiding, building searches, locating explosives, etc.



During the United States Police Canine Association (USPCA) certification in 2019, our three new K-9 teams did what no other K-9 teams have done. Our K-9's took first place in narcotic detection and tracking and placed second in explosive detection. This was a great accomplishment for being first year and first-time handlers. The older dogs also certified but chose not to compete.

Macomb County Sheriff's narcotic dogs are the first and only K-9's to be trained in the odor of Soboxone.

## Marine Division

The Macomb County Sheriff's Marine patrol strives to keep everyone safe on the waterways of Macomb County through education and enforcement.



The Marine Division patrols Lake St. Clair, which has been called the busiest freshwater lake in the world. It is renowned for its fishing and fisherman from across the Midwest travel to Lake St. Clair as a top fishing destination. During the boating season there are also various special events that are held on Lake St. Clair with the marine Division deploying resources with a specific emphasis placed on promoting water a safety whether it be a sanctioned event or non-sanctioned event; Jobbie-Nooner and Raft Off. Lake St. Clair covers approximately 85 square miles with 30.5 miles of shoreline connecting to 57 miles of rivers and

The Sheriff's Marine Division is responsible for enforcing Michigan Marine law, investigating boat accidents, conducting livery inspections, search and rescue operations, ice rescues, body recovery and instructing safe boating classes. Working with the assistance of 75 volunteer Marine Reserve Deputies allows us to meet those responsibilities. In 2019, the reserve unit voluntarily dedicated 10,977 hours to the Marine Division's primary mission of marine safety.

The division also works with federal agencies to assist in Border Security and was an active partner in the Department of Homeland Security grant funded Operation Stonegarden initiative. The Operation Stonegarden initiative supports cooperation and coordination in the joint effort to secure the US border(s) to include international water borders.

## Marine Division

### Boater's Safety Instruction

The Marine Division teaches the state approved boater's safety course "Boat Michigan – a course on responsible boating". During the winter months our deputies are primarily in the seventh grade classes, teaching boaters' safety at both public and private schools. Our marine reservists teach the same classes to adult learners. In 2019, the Marine Division instructed 5,050 students on boating safety. Macomb County leads the state in the amount of boating safety students we teach every year.

## Dive Team

The Macomb County Sheriff's Underwater Search and Recovery Team (MCSO USRT) is tasked with the recovery of evidence and persons. The team is comprised of 12 members. The Macomb County Sheriff's Office Underwater Search and Recovery Team is the only active member in the Urban Areas Security Initiative (UASI), from which funding was obtained for training.

The MCSO USRT trains once a month in several different types of environments. Training ensures that the deputies stay familiar with their equipment and become more accustomed to different types of dive environments. Some of the environments trained in 2019 include swift current in the local rivers, heavy vegetation areas in Lake St. Clair, blackout conditions in the Clinton River and ice diving during the winter months.

The MCSO USRT was utilized 11 times in 2019. These call outs were for body recoveries, evidence and property recoveries and to assist other agencies. MCSO USRT strives to continue with successful recoveries in the future.

## Court Security

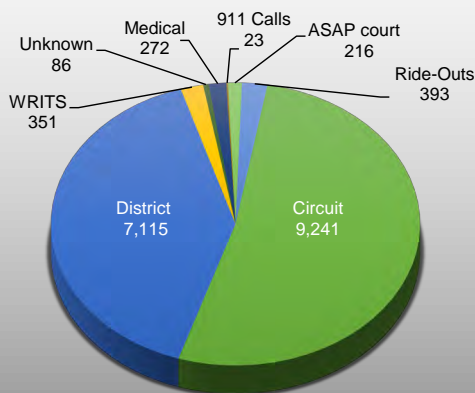
The Macomb County Sheriff's Office Court Security Division is responsible for providing safety and security to the judges, courthouse staff, lawyers, inmates, and public. This also includes security for the offices of the County Commissioners, Prosecutors, and Treasurer's Office, Fiend of the court, Probate court, Old County Building, Reimbursement, Probation Department, and other ancillary offices of Macomb County within the locations listed above.



It is the duty of the Protective Service Officers to screen the public for any items that could be considered weapons when entering the county buildings. In 2019, the Macomb County Probate Court moved from 440 N. Rose St., Mt. Clemens to the Circuit Court Building. This move increased the amount of foot traffic at circuit court and created an increased amount of screenings.

A Deputy Sheriff is assigned to each Judge to maintain order in the courtroom. Each Deputy is trained in Emergency Responses such as building evacuations, bomb threats, barricaded gunman or hostage situations, first responder to an "active shooter" situation, crowd control and first aid (CPR/AED).

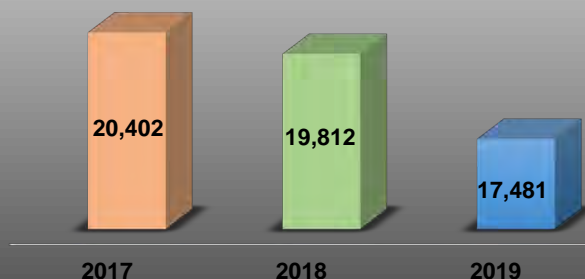


The Sheriff's Office is also responsible for the transporting of inmates to the District Courts and the 16th Circuit Court for arraignments, trials and sentencing.

The District Courts include 37-B Centerline, 41-B Clinton Township, 38th Eastpointe, 42-2 New Baltimore, 42-1Romeo, 39th Roseville, 41-A Shelby Township, 40th St. Clair Shores, 41-A Sterling Heights, and 37 -A Warren. Other prisoner transports include but

are not limited to hospitals, prisons, in and out of state warrant pickups, and psychological testing centers. In 2019, approximately 241,770 miles were logged by the Prisoner Transport Division.

## Liquor Enforcement

The Macomb County Sheriff's Office, under the authority of PA 58 of 1998, enforces the provisions of the statute of the Michigan Liquor Control Code. The responsibilities granted to the sheriff include:

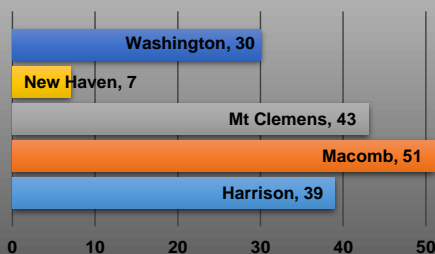
- 1) Inspections of licensed establishments.
- 2) Conducting criminal background checks on all new and transfer liquor license applications.
- 3) Ensuring that the building housing the licensed establishment meets local code.
- 4) Granting special one-day liquor licenses.
- 5) Conducting investigation at licensed establishments targeting the sale and consumption of alcoholic beverages by minors.

In addition to the duties assigned to deputies in our patrol areas, they also conduct inspections of licensed liquor establishments throughout the year. These inspections are done randomly and verify that the licensees are operating within the guidelines established by the Liquor Control Commission.

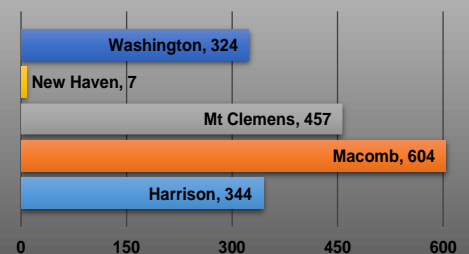
The Sheriff's Office also receives requests by the Liquor Control Commission to investigate complaints that are filed directly with the L.C.C. Many of these complaints involve a suspension or the placing "in escrow" of a liquor license due to lack or proper documentation (insurance certificates), or the temporary suspension due to the seasonal nature of the business by the licensee.

In 2019, thirty-three special permits were issued to non-profit groups wishing to sell alcoholic beverages at special events within the Macomb Sheriff's patrol jurisdiction.

Liquor Inspections By Venue

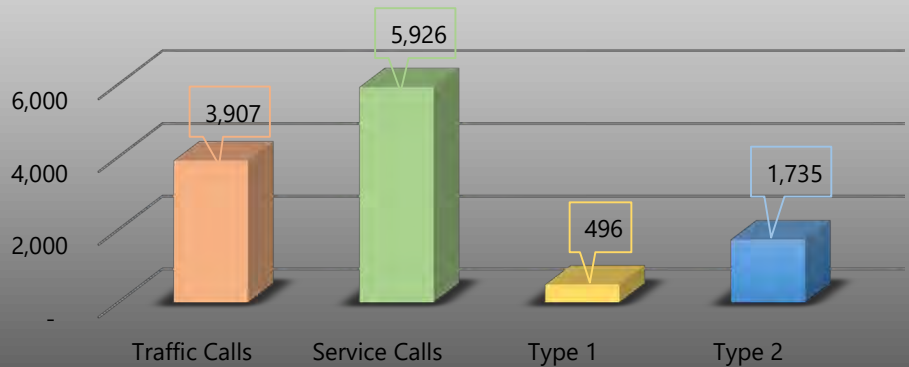
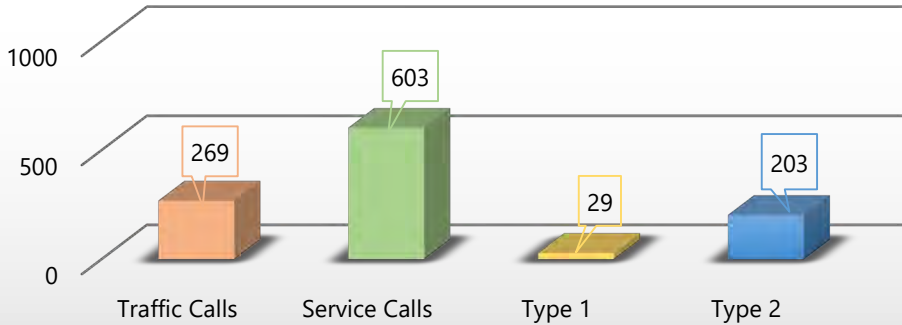
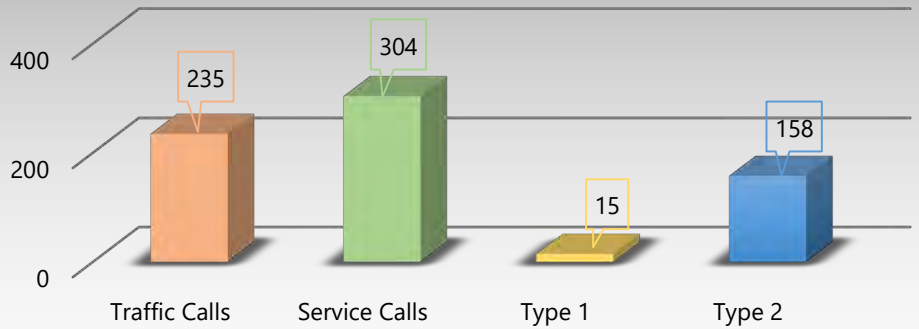

# Administrative Services

## Detective Bureau



The Detective Bureau conducts investigations for the:

*Townships of Armada, Bruce, Harrison, Lenox, Macomb, Ray, Richmond and Washington; the City of Mt. Clemens and the Village of New Haven.*

The Bureau staff consists of four supervisors including one lieutenant and three sergeants, thirteen detectives, and two clerical staff. In addition to their regular duties, each supervisor has additional responsibilities that require special attention. Those responsibilities include the oversight of the Macomb County Strangulation Response Team, Crash Investigation Unit, Polygraph Unit, Youth Bureau, and Friend of the Court (F.O.C.) Enforcement Unit.

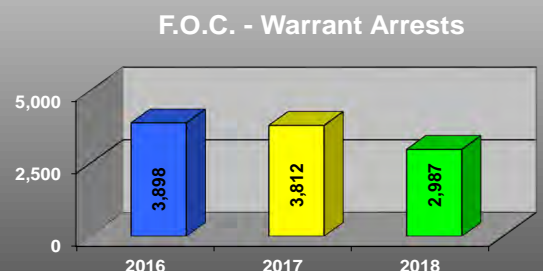
In 2019, the MCSO Detective Bureau handled a total of 3,641 cases compared to 3,521 cases in 2018.

## Friend of the Court (F.O.C.)

There are six Deputies assigned to the FOC Enforcement Unit. The FOC Unit works in conjunction with the Friend of the Court to enforce support orders. There are two (2) 2-person arrest teams who actively pursue and arrest those who fail to make court ordered child support payments. Additionally, two (2) FOC deputies are assigned to the FOC Office who provide intelligence for the two enforcement arrest teams.

Friend of the Court enforcement deputies affected 2082 arrests/resolutions for bench and other arrest warrant for failure to pay child support in 2019. The total amount of arrearages accounted for by those arrest equals \$16,646,357.00.

## Youth Bureau Services

The Youth Bureau is comprised of one Investigator, one D.A.R.E. Officer, and three School Resource officers (S.R.O.). The S.R.O. Deputies are assigned to the Chippewa Valley and Romeo School Districts.

The Youth Bureau handled 218 investigative complaints in 2019. This compares to 235 investigative complaints in 2018.

Two S.R.O. Deputies are assigned to the Chippewa Valley Schools campus in Macomb Township; one is based out of Dakota High School and 9th grade center and the second is assigned to the elementary and middle schools. A third S.R.O. is assigned to the Romeo School District which is comprised of four elementary schools, two middle schools, and two high schools.



One additional Deputy is assigned to the Drug Abuse Resistance and Education (D.A.R.E.) position. This Deputy facilitates education to students in the Chippewa valley, Mt. Clemens, and Utica School Districts as well as to four private schools. D.A.R.E. is a 10 week curriculum taught one day a week in each class and then there is a graduation ceremony. Students are awarded for participation and for their individual accomplishments. Approximately 1,300 fifth and sixth grade students from 16 different schools graduated from the D.A.R.E. program during the 2018-2019 school year.

In 2019, The Macomb County Sheriff's Office implemented a new "Inside View" Program. Inside View is a program to encourage young people, ages 12-17, to weigh the consequences of their actions. This program is a firsthand look into the life of an inmate at the Macomb County Jail. Participants are given a brief tour of the jail by our correctional deputies and hear testimonials and straight talk from inmates that are currently incarcerated. Inside View gives adolescents a good hard look at what happens when poor decision's turn into life changing consequences.

## *Crash Investigations Unit (C.I.U.)*

The crash investigation unit (C.I.U.) is comprised of four Deputies and two Sergeants. The unit's primary function is to investigate fatal crashes or serious injury crashes likely to result in a fatality. The unit is also responsible for the reconstruction of all crashes resulting in criminal prosecution. Additionally, the crash unit is responsible for insuring that all evidence is documented, photographed, and collected so a thorough investigation and/or reconstruction can be completed.



The CIU was activated 17 times in 2019. Of the 17 activations, seven were fatalities, two were serious injury crashes, and eight were crash investigations for outside agencies. Three full crash reconstructions were completed. The CIU was also requested to assist with scanning (FARO) on six different cases for outside agencies, specifically four homicides, one officer involved shooting, and one stabbing.

## *Evidence Technicians*

Although deputies assigned as evidence technicians may assist in handling calls for service, their primary role at a crime scene is the collections, preservation and processing of evidence. Macomb County Sheriff's Office evidence technicians not only function in that capacity of the Sheriff's Office, but also assist other local law enforcement agencies as requested. This year, 22,653 items were taken into the property room.



## *Polygraph*



One deputy is assigned as a polygraph examiner to conduct polygraph examinations for the Sheriff's Office as well as other local police agency investigations. In 2019, there were 121 polygraph cases scheduled. Of the 121 cases, 21 were cancelled and 25 were not conducted due to subjects failing to appear. Polygraph examinations that were conducted resulted in 23 "deception indicated", 27 "no deception indicated", 9 "inconclusive", and 2 with significant or no significant reaction.

In 14 of the polygraph examinations, the polygraph operator was able to obtain pre-test confessions.

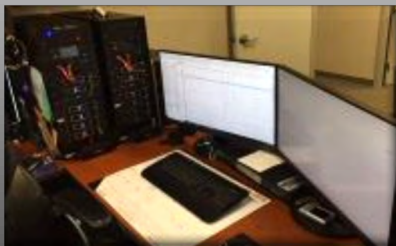
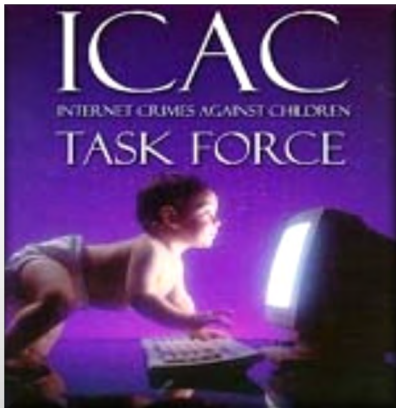
## Macomb Area Computer Enforcement (M.A.C.E.)

The Macomb Area Computer Enforcement unit (M.A.C.E.) is a computer crime task force assigned to investigate computer crimes such as computer fraud, identity theft, and child sexual exploitations. This year, the unit opened 839 cases and arrested 29 subjects for various criminal activities.

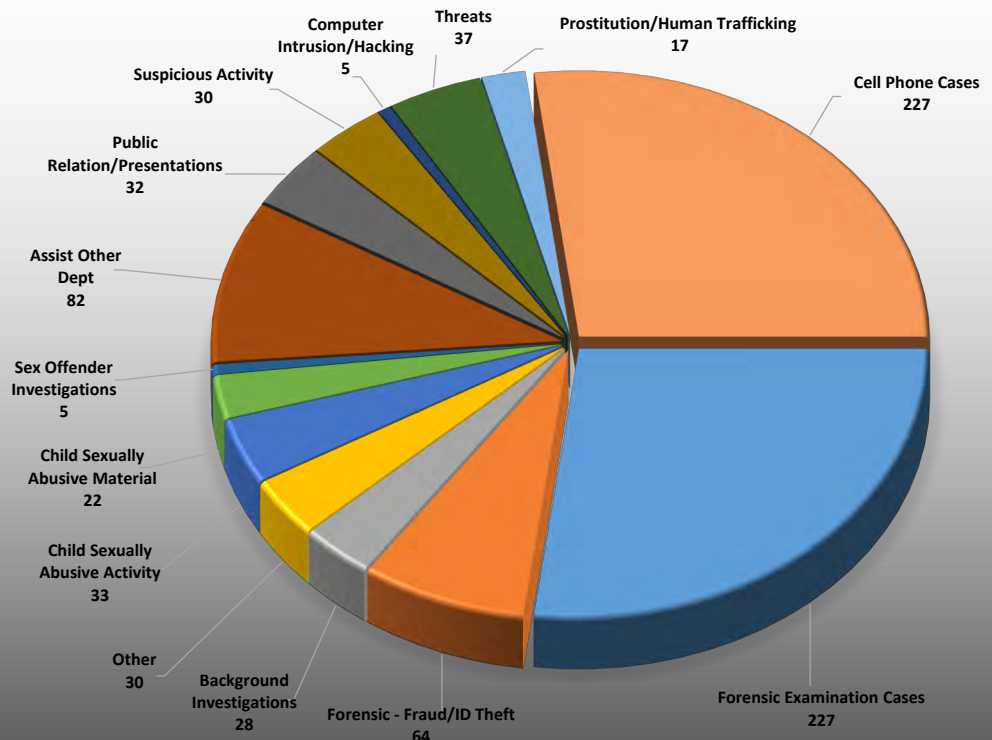
Computer crimes are often difficult to investigate due to crossing jurisdictional lines, as well as the increase in communication technology available: such as smart phones and on-line games through which children are solicited. M.A.C.E investigators assist other local law enforcement agencies with computer crime investigations.

M.A.C.E. maintains partnerships with Michigan ICAC (Internet Crimes Against Children), and UASI Region 2 Cyber Security.

M.A.C.E. continues to assist with education and prevention endeavors in local schools educating all grade levels of students, teachers and parents regarding cyber crime and safe use of the Internet. M.A.C.E also presents internet safety seminars for senior citizen and church groups.

## *Sheriff Enforcement Team (S.E.T.)*

The Sheriff's Enforcement Team (SET) provides undercover police services working under the authority of Macomb County Sheriff Anthony Wickersham. Detectives assigned to SET conduct narcotics related investigations, apprehend fugitives, conduct surveillance, and investigate high profile cases which may include homicide, robberies, residential break-ins and assaultive crimes. To complete the mission at SET investigators rely on crime reports, anonymous tips, confidential informants and established traditional methods of police work.



Bureaus within the SET unit include the Narcotics Bureau, U.S. Marshal Task Force (DFAT), MACE, Drug Enforcement Agency (DEA), and the FBI Task Force. During 2019, the SET Unit investigated more than 1,850 cases, executed over 60 physical search warrants and 220 administrative search warrants related to electronic forensics. These investigations resulted in 350 arrests, which included multiple child sexually abusive activity cases, human trafficking, narcotics related cases, homicide, home invasions, armed robberies, and violent felony warrant arrests.



The SET Unit seized and forfeited over \$200,000 in cash and property to be auctioned. Approximately \$120,000 in narcotics were taken off the streets of Macomb County.

## *Drug Enforcement Agency (D.E.A.)*



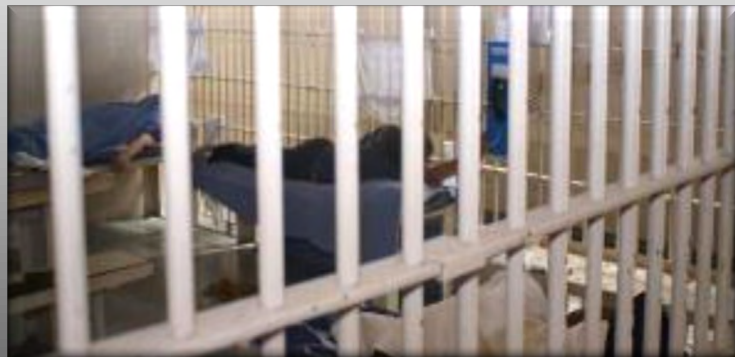
The Sheriff's Office has two deputies assigned to the Drug Enforcement Agency (D.E.A.) to investigate large scale drug traffickers. One of these two deputies is assigned to a new DEA group task force focusing on the heroin, fentanyl and car-fentanyl crisis in our area. This DEA task force group formed in 2019 has been

called Federal Anti-Narcotics Team Of Macomb (Fantom). Deputies assigned to these task force teams conduct covert investigations that can reach beyond the southeast Michigan region, across the United States and beyond the U.S. border. During 2019, the DEA reimbursed the Sheriff's Office approximately \$30,000 in overtime costs.



## *Fugitive Apprehension*

The Sheriff's Office has one sergeant and one deputy assigned to the U.S. Marshal's Detroit Fugitive Apprehension Team (DFAT). The purpose of this task force is to pursue and arrest local, state and federal fugitives. In 2019, DFAT arrested 226 persons with a combined total of 252 warrants. The U.S. Marshals reimbursed the Sheriff's office over \$35,000 in overtime costs and contributed additional funding in the form of vehicles, gasoline, and other tactical gear and training.

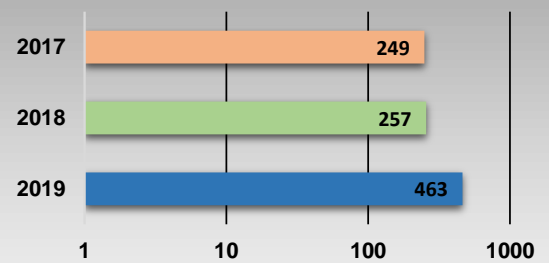

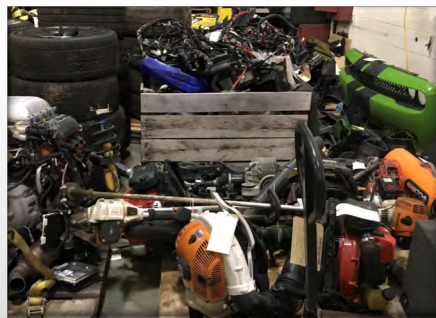
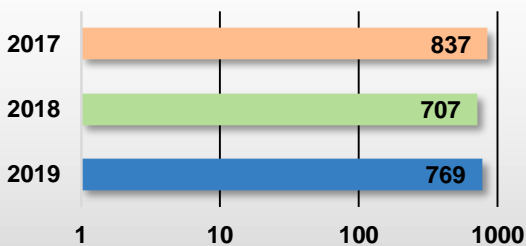
## Macomb Auto Theft Squad (M.A.T.S.)

The Macomb Auto Theft Squad is a multi-jurisdictional task force comprised of investigators from the Macomb County Sheriff's Office, Centerline Department of Public Safety, Clinton Township Police Department, Eastpointe Police Department, Roseville Police Department, Shelby Township Police Department, St. Clair Shores Police Department, Sterling Heights Police Department and the Warren Police department. The unit's manpower totals eleven Detectives and one full time secretary. In addition, the Macomb County Prosecutor's Office received funding to provide a full time assistant prosecutor to the squad to prosecute all cases generated by M.A.T.S. and to initiate forfeiture proceedings as mandated by law. The Macomb Auto Theft Squad investigates auto theft and its related crimes including insurance fraud. In 2019, the 769 opened investigations included but were not limited to Car Jacking, UDAA, LFA, and Fraudulent Activities. In 2019, MATS Detectives recovered approximately \$5,650,934.00 in vehicle recoveries which were returned back to the insurance companies

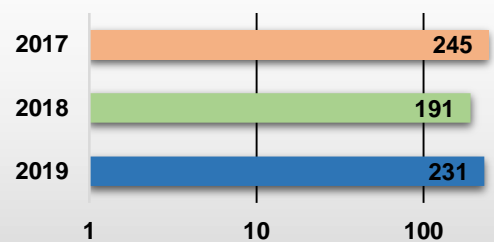
2017-2019 Vehicles Recovered by MATS

The Macomb Auto Theft Squad received funding from the Michigan Automobile Theft Prevention Authority (ATPA). The ATPA is funded by an annual assessment on automobile insurance companies at \$1 per motor vehicle including passenger and commercial motor vehicles. Since the inception of the ATPA in 1986, auto thefts in Michigan has decreased by 62%. Nationally, thefts have decreased by almost 40% as well. ATPA's success in the battle against auto theft is the direct result of dedication and efforts of the men and women who are apart of law enforcement agencies, prosecutor offices, and community organizations. \*Michigan State Police, Automobile Theft Prevention Authority.

## Special Weapons and Tactics (S.W.A.T.)

The Macomb County Sheriff's Office SWAT team is a multi-jurisdictional response unit which provides tactical support to any agency requesting assistance with high-risk, potentially life threatening situations. Responses include, but are not limited to the following: Barricaded Subject(s), snipping incidents, search and arrest warrants - when considered high-risk, terrorist events, hostage situations, workplace and school violence situations, and executive protection. SWAT team members include law enforcement officers as well as medical personnel. The team trains two days per month, completes one week of specialized training, and one week of refresher training per year. The Macomb County Sheriff SWAT team is currently the only team regionally that meets the level two type criteria on a national level. In 2019, there were a total of 27 SWAT operators and 4 medical personnel.

In 2019, The Macomb County Sheriff SWAT team received three calls for service. Two of the calls resolved themselves before the team arrived. The third call was to assist another agency with a barricaded suspect in his residence. The suspect had shot at his significant other, innocent bystanders, and police. The standoff had lasted almost 24 hours before we were called to provide relief. With various tactical tools and personnel, the team made entry and was able to locate the suspect and significant other deceased.



# Administrative Services

## Training Division

The Training Division is responsible for all training of Macomb County Sheriff's Office officers and support staff. This includes new hires, promotions, and record tracking required by the state. In addition, the Training Division is responsible for recruitment, facilitating presentations, and jail tours to various community groups.

In 2019, 13 in-service training days were conducted covering all three shifts. In total, 35,097 hours of agency training were completed. All MCOLES, MSCTC, and PSAP requirements were met for all officers.

Some of the top Training Division accomplishments for 2019 included hosting a speaker for Cultural Diversity. Rescue Task Force training was conducted at Mt. Clemens High School with SWAT team instructors and interns for role players. Fifteen deputies were certified to instruct Crisis Intervention Training. Five separate training days were utilized for suicide awareness for the jail. Also, medical emergency bags were purchased and filled with a tourniquet, bandages, Hyfin chest seal, Narcan, cut down tool and a towel. These bags were placed in the jail duty stations and staff were trained on all of them.

Sheriff Wickersham continues to support citizens of Macomb County with the opportunity to have job shadowing education based opportunities. A youth academy for Macomb County high school students was held and every high school in the county was invited to send students interested in careers in law enforcement. Sixteen students were educated in forensics, evidence collection, investigations, traffic, and other specialized units of the Macomb County Sheriff's Office. Two senior academies were conducted for over 200 seniors in Macomb County. The four-week series of classes were to educate seniors about the operations of the Macomb County Sheriff's Office and its different divisions.

## Firearms Training Division



The Firearms Division of the Sheriff's office conducted training and qualifications for over 650 people on our range, some on as many as four weapon systems. Qualifications included departmental qualifications, state assessments, reserve qualifications, corrections and clerical CPL training, and PSO qualifications. Firearms and Taser training included weapon operation, handling proficiency, tactics, marksmanship and subject control. In 2019, over 40,000 rounds of ammunition for qualification and training purposes were expended.

In 2019, the Firearms Division conducted 2 CPL classes for corrections and clerical staff. These classes allowed 30 departmental personnel to fulfill the requirements necessary to obtain their CPL in a convenient manner and at substantial cost savings to them.

The Firearms Division continued to assist in the expansion of the C.E.R.T. team for the jail. This was formed to control unruly inmates and respond to critical incidents within the jail. Corrections deputies were trained and equipped to handle nearly any situation that may arise in the jail. They were equipped with stab proof vests, helmets, goggles, gloves, shields, Tasers, and Pepperball guns. The C.E.R.T. team has been utilized over 75 times for potentially violent inmates. No injuries have been sustained during any of these incidents, by either deputies or inmates.

## Reserve Units

Community involvement is one of the key missions of the Sheriff's Office, and that is no more evident than with the Reserve Units. There are eight distinct units: A.C.E., ATV, Aviation, Cyber Crimes, Marine, Mountain Bike, Mounted, and Motorcycle. Members of each unit volunteer their time and their own equipment to assist the Sheriff's Office. Two other volunteer groups who donate their time to serve the citizens of Macomb County are Senior Volunteers and Explorers.

The 22,610 hours the reserves and volunteers donated in 2019 is equivalent to \$713,345 in funding for the county.

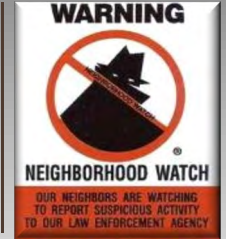

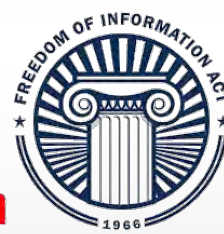
# Records Office

Our staff works diligently to process all requests in a timely manner.

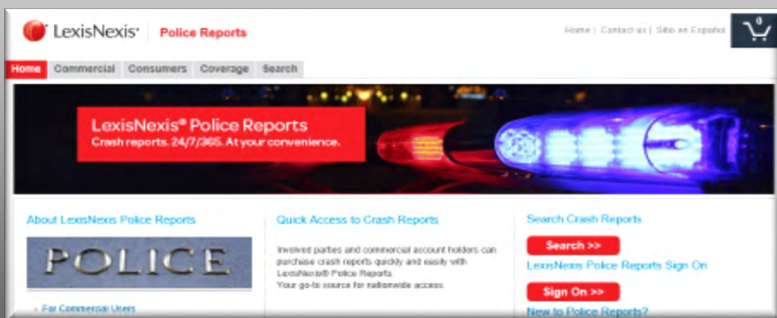

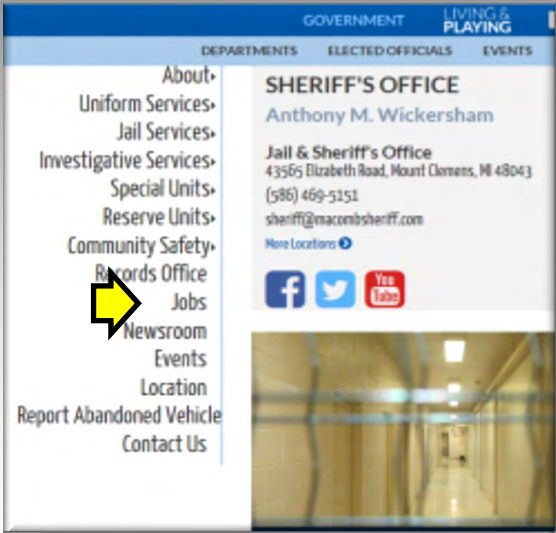
